Community Drainage Project

The HOA has asked to be apprised of when the Road Project commences and the

schedule of the project.

The HOA will work with the CDD to notify residents and the major vendors who are

regularly in the community.

The Boards discussed that this will include garbage and recycling pickup, which both

occur on Mondays. Also discussed notifying landscape vendors. The HOA and CDD will

coordinate to develop a plan as to how best to contact as many vendors as possible.

Stop Signs and Road Bumps

The HOA gave all pertinent documentation to their attorney to determine if stop signs

and speed bumps can be installed in certain areas with or without CDD approval and what

other permits or approvals might be needed.

The HOA will keep the CDD apprised as to the determination of these matters.

Security Company

The HOA discussed switching their security vehicle from a rover car to a golf cart but

ultimately decided to keep the car. Contrary to rumors and misinformation, the HOA is not

asking the CDD for financial help with the Security Rover.

The HOA is considering installing a "Traffic Hawk" to control speeding in the community.

The HOA will keep the CDD apprised as to the determination of these matters.
